Korea-Cambodia REDD+ Joint Project

I. Introduction

The Forest Administration (FA) signed a MOU with Korea Forest Service (KFS) on 10th December 2014 to implement the project namely Korea-Cambodia Reducing Emissions from Deforestation and Forest Degradation (REDD+) Joint Project (KCRP). The project is implementing within 4 years (2015-2018) which covers an area of 70,042 hectares in Kampong Thom province. The FA is a project implementation agency with financial support from the KFS, the Wildlife Works Carbon (WWC) is a project carbon developer. The project aims to contribute to the long-term greenhouse gas emission reduction from forestry sector and enhances livelihood of targeted forest-depended community in the project area through the implementation REDD+ program. The project seeks to certify under VCS and CCBA standard for issuing its REDD+ verified credits.

Report Timeframe

This is a quarterly report (01 July – 30 Sep 2017), the report was consolidated from individual project specialist's reports and field project semi-reports. The project specialists' reports are available up on request.

II. <u>Progress on the Project Management, Administration, and Stakeholder</u> coordination

- In this quarterly, the Administration and Finical Officer resigned in August 2017, the PMU recruited an Administration and Financial Consultant to work temporary, the payment for the consultant is made based on deliverables produced.
- The PMU in with the approval the Kampong Thom FA cantonment established the Project Sub-office which was located inside the Sandan FA division (Tumring Commune Town). The project also recruited a community engagement assistant to work base in the project sub-office, the main term of reference of the community engagement assist is mainly communicate regularly with all community forestry and local stakeholders to ensure effective monitoring of the community forestry performance their daily activities and issue to be raised by local stakeholders are addressed.
- In this quarterly, the PMU purchased 06 GPSs and handed-over to the 06-community forest management committees (Kbal Dautey, O's Kra Nouk, Neak Tala, Chaom Smach, Rom Chek). The GPSs to be used by CFMCS will fuel the effort of the CFMC to fight against deforestation and forest logging in their managed territory, and it will be used to track geo-information for reporting and take urgent action against illegal forest activities.
- The PMU attended and presented the TRP during the Prey Lang Working group meeting and REDD+ information sharing, the meeting was held in Kampong Thom province on 14-16 Aug 2017, Ponleu Thmey and Kampong Thom Provincial Department of Environment. The meeting aimed to understand current status of Prey Lang and identify key issues happened in the Prey Lang after becoming wildlife sanctuary and to understand the communities' perspectives on how to manage and control forest resource in effective and coordination way between forest-dependent community and specialized government departments. There were various NGOs,

community representatives and specialized Government departments attended for 3 days meeting and field visit with total participants 41 included 5 females attended. Please kindly see the attached files such as NGOF, MB, AFD, CPN, DPA, PBO, Winrock, PLCN NTFP-EP, Danmmision, WWF, EHEO, CLEC, Home network, PKH, community representative from Mondulkiri.

III. Results against project specific objectives

Objective1: Obtain forest carbon credits from the Korea-Cambodia Joint REDD+ implementation. Through the project implementation process, the project aims to bring REDD+ credits to the volunteer carbon market and it is subjected to be certified under CCBA and VCS standard.

VCS&CCB PDD Validation

- The PMU with technical support from the WWC are working on the respond to the project validation findings, the finding encompassed of 8 VCS corrective action request (CARs) and 14 CCBA- CARs. It is expected that a set of documents and responding will be submitted to the validation (SCS) by late of Oct 2017. (Annex I: Respond to the SCS's finding)
- The Tumring REDD+ PDD version 2.7 (23 Oct 2017) was revised after receiving inputs from the public comments and comments from the validators (SCS). The PDD will be finalized after received an approval from the validator (SCS).

Objective2: Increase livelihood of forest dwellers within target Korea-Cambodia Joint REDD+ implementation site. The project will improve livelihood of forest depended communities who are living inside and adjacent the REDD+ project site.

 The Tumring REDD+ provides regularly support to the forest law enforcement unit (FIU), and community forestry groups. Both CF groups and the FIU regularly submit enforcement report to the PMU against the payment. As always, the PMU summary the results as an outcome from the forest law enforcement activities from both community forest patrol groups and FIU.

<u>Tumring REDD+ Livelihood Program Development</u>

- As part of the Tumring REDD+ Community Livelihood Idea Note-2017, the PMU facilitated several activities aims to meet the key milestones set in the improving livelihood of local community participated in the implementation of Tumring REDD+ project.
- Solar System Charging for Home Battery: The PMU conducted with Khmer Solar company to install the solar system for home battery charging, the contract worth 4,000 USD, and community member contributed 200 USD (mainly to cover the cost of building the center). The center and Solar System Charging for Home Battery (SSCHB) have been completed constructed. The center will be fully operation in the late of December 2017, the community member conducted dissemination information to the all community forestry members in 06 villages (Por Roung, An Sar, Tra Yorngg, Pren, Krang and Sre Pring) about the center. The PMU facilitated CFMCs to develop Solar System Charging for Home Battery (SSCHB) regulation and procedure in managing fund. The finance to be generated from the Solar System Charging for Home Battery (SSCHB) operation will be used to maintain the operationalization of the center, and contribute to community forestry management.

Objective 3: enhance capacity of key different stakeholders to effective REDD+ implementation. The project will improve capacity of targeted communities and government stakeholders

• Conduct regularly meeting with the CFMCs, the meeting aimed to review the status of the community forestry performance and address problem raised by each community forestry, and on-going collection other TRP associated information such as development partners working in the area, information on saving groups, revolving fund/microcredit, livelihood program, community enforcement activities and solar program, that information will be utilized for improving the TRP strategic plan. Within two months (July and August 2017), the community engagement specialist conducted meetings with all 14 community forestry groups which comprised of 140 CFMCs.

 The community engagement specialist provided a training to the 06 community forestry management committees on the use of GPS and procedure in filling the community patrol form and reporting. The training aimed to building technical capacity of the 06 CFs which comprised of 27 CFCMs, these CFMCs recently received support of 06 GPSs from the project.

• Part of the project's strategy to address drivers of deforestation and forest degradation, the PMU will pilot the agricultural land assessment toward the designing of participatory land use planning and secure land right. At the phase first, the TRP conduct agricultural land assessment inside 04 community forestry. The CFMCs were trained by the project on how to conduct agricultural land demarcation, recording land information, and tenure right information; the training conducted with 31 CFMCs participated. After the training, the CFMCs conducted actual field demarcation, as result, by Sep 2017; the CFMCs demarcated 23 plots of agricultural land in 04 community forestry. The agricultural land information was properly stored in the project database.

- The PMU working closely with the CFMCs and local FA facilitating the establishment of the community information board. As planned, the TRP will support the establishment of 17 community information boards to be installed in 14 community forestry. By Sep 2017, 04 boards were installed, and it remaining boards are expected to be completely installation by next quarterly. The objective of the establishing the community information board is to disseminate information to ordinary community members about the TRP.
- The PMU conducted a three days information dissemination about the progress made by the TRP over the last two years and six months to the community members, and presented the next work-plan. The disseminate events were conducted in four community forestry, participated by 84 community members.
