I. Introduction

The Forest Administration (FA) signed a MoU with Korea Forest Service (KFS) on 10th December 2014 to implement the project namely Korea-Cambodia Reducing Emissions from Deforestation and Forest Degradation (REDD+) Joint Project (KCRP). The project is implementing within 4 years (2015-2018) which covers an area (PA) of 67,791.17 hectares in Kampong Thom province, and Project Accounting Area (PAA) is 41,195.00. FA is a project implementation agency with financial support from the KFS, the Wildlife Works Carbon (WWC) is a project carbon developer. The project aims to contribute to the long-term greenhouse gas emission reduction from forestry sector and enhances livelihood of targeted forest-depended community in the project area through the implementation REDD+ program. The project is seeking for certification under VCS and CCBA standard for issuing its REDD+ verified credits. The project is expected to generate net annual emission reduction (NERs) of 385,333 tCO₂e, and 11,559,975 tCO₂e over 30 years (2016-2025) of the project life.

Report Timeframe

This is the third quarterly report from 01 July – 30 September 2018, the report was consolidated from individual project specialist 's reports and field project semi-reports.

II. Results against project specific objectives

Objective1: Obtain forest carbon credits from the Korea-Cambodia Joint REDD+ implementation. Through the project implementation process, the project aims to bring REDD+ credits to the volunteer carbon market and it is subjected to be certified under CCBA and VCS standard

Project validation: The project received a successful validation in Sept, 2018. It was registered at VCS and Markit. Several reports had been produced by PMU, third party validator (SCS) and carbon developer (WWC), those were posted in the VCS and market's web-page. Preparation for verification: the field verification is expected to be conducted in mid of 2019, as part of the process, the project proponent (Forestry Administration) were asked by the validator to (1) conduct second SBIA in part of Southwest of the project site, write-up the project implementation report (PIR), and preparation for verification that including at least 20 percent of the PSPs

established in the project accounting area to be re-measured, and conducting local stakeholder meetings and household interview. In addition, to the writ-up of PIR, there was some requirements associated to collecting social, biodiversity data, and verify forest carbon stocks (assessment of the actual forest land use change) prior to the actual field verification happened.

The PMU is negotiating with WWC on the second phase of partnership agreement on support to for the Tumring REDD+ verification, the PMU have draft partnership agreement and budget plan for WWC engagement, however, availability of the budget for verification is depend on the sign of amendment MoU between FA and KSF for the next years support (2018-2019). Once the MoU to be signed by both parties, the PMU will move ahead with approval of the WWC's budget proposal for verification phase.

Objective2: Increase livelihood of forest dwellers within target Korea-Cambodia Joint REDD+ implementation site. The project will improve livelihood of forest depended communities who are living inside and adjacent the REDD+ project site

Forest Law Enforcement and Forest Protection (Strategy#2)

Contributing to the implementation of the <u>strategy#2</u> of the 30 Year Work Plan (Tumring REDD+ Project). The project is supporting 14 community forestry, and forest law enforcement unit of FA to conduct regular forest patrol. In this quarter, enforcement teams achieved the results below:

Forest law enforcement coordinator conducted regular meeting with FIU focused on: the current status of forest law enforcement, and community forest patrol. Through the meeting, FIU will further supporting community forest patrol by joint patrol and increased forest law enforcement campaign in Q4, 2018.

As part of the forest law enforcement campaign, in September, 2018, FIU cracked-down large-scale forest logging at the adjacent area of the project site, as results, the enforcement team confiscated of 01 excavator, 01 bulldozer, 02 chainsaws, and 02 motorbikes. All confiscated tools were maintained in the FA cantonment office, while the team is filing complaint to court.

Enhance forest livelihood and increase local income local community (Strategy#3)

Community Saving Groups, Community saving group, by September 2018, community saving group has earned of USD 158 from the interest rate, with the saving capital of USD 2000. The save group received knowledge on how saving group associated with forest conservation. In the second phase of the project, the project will scale up and increase number of communities saving groups in the second phase of the project implementation including activity to assess its impact.

Solar System Charging Center for Home Battery, the SCCHB is operating under the management of Socheat CF, Por Ro village. By September, 2018, the SSCCHB has provide service to 542 home based-batteries and earned USD193. To promote SSCCHB, the community assistants have been promoted and disseminated the important of using SSCCHB to community members and associated information to forest conservation.

Supporting re-election of community forestry committees, the Tumring-REDD+ project within this quarter has been supported 3 CFs (Ou Bosleav, Ou Thmor and Romchek) to re-elect their new community forestry management committees (CFMCs) in collaboration with local authority and local FA. As results, three CFMCs were endorsed by the local authority.

Improve degraded agricultural land, in this quarter, the PMU cooperated with provincial department of the Office of Agronomy and Agricultural Productivity, Provincial Department of Agriculture, Forestry and Fishery Kampong Thom conduct activities as below:

- Conducted three village workshops, the village workshops were conducted aimed to (1) provide overview about connection between benefits of improving agricultural land improvement and forest conservation under REDD+ implementation, (2) improve agricultural land through the enhancement of degraded land, and (3) disseminated and shared plan of support from the project that aimed to reduce forest land clearing.

Support the development free-deforestation value chain of the selected agricultural commodities, in this quarter, the project partner, AFD, conducted significance activities as set in PMU and AFD partnership agreement signed.

- The two times commune meetings were conducted, and interviewed with 12 local traders in Mean Rith and Tumring commune by AFD staffs and representative from provincial agricultural officers. The commune meetings were conducted aimed to inform farmers about REDD+ project and increase their knowledge on the impact of agricultural land expansion

into forest area, trad associated with deforestation in the project area. the commune meeting participated by traders, farmer, local authorities, and provincial agricultural officers. The results from the local trader interviewed were sent to PMU for reporting and further analysis.

AFD and the provincial agricultural officers conducted two commune meetings aims to increase knowledge on concept of the establishment of Agricultural Cooperative (AC) and developed a work-plan, process in establishing AC, and increased awareness on rules and regulations to guide AC development.

- AFD and Provincial agricultural staff conduct an interim AC committee selection in Tumring and Mean Rith commune. As results of election, two interim groups were formed, for a group of Mean Rith consisted of 15 members (01 women) and a group of Tumring consisted of 15 members (2 women). Those two groups were endorsed by the commune council.
- The commune council and AFD officer issued the announcement posted in 14 villages (11 villages in Mean Rith and 4 villages in Tumring) provisioned to recruit qualify candidates to be elected as official committee and board of committee of AC.

The selected interim AC committee with technical support from AFD staffs and provincial agricultural staffs conducted consultative meeting with its members to develop AC's by-law and regulation. Since the project have supported the establishment of two ACs in Tumring and Mean Rith commune, both ACs s' by-laws and regulations were developed within two communes and being disseminated among its members to further collect feedbacks and inputs prior to its endorsement.

- The drafted by-laws and regulations consisted of key elements to govern performance of ACs such as defining name of the ACs, clarify of roles and responsibilities of AC board committee and its members, business plans, and grievance mechanism as such. The drafted by-laws and regulations will be officially approved by its members and AC board committee during its commune submit.
- The AFD staffs organized meeting with commune council, the meetings were focused on the support of the establishment of two ACs in Mean Rith and Tumring, include presented the proposal on location of ACs to be set up, procedure in collecting/buying agricultural commodities, storage and other associated issues.

Objective 3: enhance capacity of key different stakeholders to effective REDD+ implementation. The project will improve capacity of targeted communities and government stakeholders

Increase stakeholder participations in reducing deforestation and forest degradation in Tumring REDD+ Project area (Strategy#4)

Building capacity of Community Forest Management Committee (CFMCs), The PMU in closed collaboration with local Forestry Administration (FA) and local authorities facilitated community forestry to re-elect the community forest management committee, this is due to the ended mandat of community forestry management structure, and it provisions in the community forest sub-degrees (2013). The events were conducted in O Bosleve, Prey O's Thmor, and Rom Check community forestry. As results, three community forest management committee (CFMC) were endorsed by the local authority with recognition letter issued.
